One item in the zoning that Pierre would like the Board to think about is that currently the Planning Board requires 2 sets of maps for a BLA, the before and after maps. He said this is in direct conflict with what is written in the Zoning Law. David said he does not think any of that is necessary. Pierre said at times it is needed for clarification and if the BLA is difficult. He also said he and the Clerk are going over the application forms (BLA, Site Plan and Subdivision) to review them and update them. Once updated, they will be put onto the website.

4. Pierre said he would like to hold Special Meetings to go over the Zoning Law; it could be done in 2 hour increments. Maybe it would only take 1 meeting but he does not think so. He and Chad will come with some dates to see what works for the Board members. Perhaps a day other than Monday so Katrina can come. Pierre will send out an email on the dates.
